4 Day Attendance Schedule

We are still on track to transition to the 4 day in person with Friday being an online learning day schedule this coming Monday, November 9th. The main factor driving this decision is the lack of spread in elementary schools. The 8 Granite District Elementary Schools which are about 2 miles away from us saw an increase of only one student over the previous week in all 8 schools.

Here are the weekly numbers of COVID cases in all those schools combined for the last 5 weeks with the most recent number listed last: 8, 10, 6, 4 and 5. So to clarify, in this last week there were 5 COVID cases combined in all 8 schools. This leads us to believe that mitigation strategies are working and that there is little to no community spread in these schools. We have made some adjustments to our mitigation strategies and are prepared to safely welcome students back on Monday.

Halloween

It was nice to see so many students and families at the Halloween parade on Friday. I appreciated how everyone wore face masks and most groups maintained the 6 foot social distancing between groups. I want you to know that I did fill out and complied with the requirements of the state's Event Management Template. I mention this because later the day of the parade is when the Governor sent out the text message about limiting gathering sizes to 10 or fewer.

I am sorry that the video recording of the parade did not work out. For some reason the computer that I was using to record did not record the parade. I had done a test just before the parade with one student for 10 seconds and it worked. When I hit the record button for the regular parade it came back with no images of the parade. Again, I am sorry this did not work.

Safety Measures

Maintaining a healthy school operation is of greatest importance as we endeavor to prevent and reduce the spread of COVID-19. Canyon Rim Academy stays informed about best practices through regular visits with local health officials, reviewing CDC guidance and through education websites. We closely monitor other neighboring schools and learn from their experience. We strive to stay well-read and informed on the best practices being adopted in elementary school settings in Utah and across the country. Scientific evidence indicates that risks to students and staff can be kept low if schools adhere to strict control measures and dynamically respond to potential outbreaks. We appreciate the resilience of all students and staff, patrons and guests, who faithfully wear their face mask every day when they enter the school.

The CARES Act passed by Congress provides financial assistance through the Coronavirus Relief Fund to aid schools as they navigate the impact of the COVID-19 outbreak. CRA has benefited from the grants made available to us. We have acquired necessary sanitization supplies and equipment not accounted for in our yearly school budget. Here is a sample of things we have purchased to benefit all students and employees: 50+ gallons of hand sanitizer, UV sterilizer light wand to disinfect keyboards after each use, non-contact thermometers, Plexi-glass, window fans that can reverse air flow, Web cameras and mics for each teacher to teach digitally, Chromebooks (there is a Chromebook shortage – we are still waiting for more), face masks, and most recently we have acquired 28 mobile air purifiers that will be in all rooms in the school where students gather. This represents some but certainly not all the things we have received.

Based upon the school's reopening plan we have tried to balance the risk of exposure with the benefits of being together for social/emotional health and educational equity. Our plan encompasses 3 goals: 1) safeguard the health and well-being of our entire community, including students, staff and families, 2) provide a high quality education for all students, no matter where the learning takes place, and 3) respond quickly to changing conditions.

We appreciate your fidelity in following the protective measures we have in place and the great example you set at home. The precautions you take at home make a difference when your child comes to school.
