- We are currently waiting for the Rise testing data. Currently unsure if funds will need to come from Land Trust we are still waiting on data.
- We would like to see not just testing data but we would like to know the social and emotional growth of students that may not test well but are doing better with peers.-Melanie

Language Arts is our greatest concern at this time-Colleen

(NEW INTERVENTION ELA PROGRAM 95% GROUP \$45,000.00-Jesse

Jesse took some time to focus on the early learning plan ELP 2023-2024 (see Attachment)

Acadience testing opposed to RISE testing focusing on early intervention (See Attachment)
Science of Reading Method (New Senate Bill 127) (See attachment)

Curriculum fund changes are usually covered in General funds however new bill equals new curriculum

- Jesse and her committee are currently researching 95% Group and KR2 and a few other ones.
- Assuming we go with 95% which will be a large one time expense and then minimal expense going forward.
- Jesse and Dave will go over the budgeting for the new program.
- Training for teachers in the new program.
- Intervention component is for K-6 grade only.
- Goal would be 70% of 3rd graders will be reading at grade level. 2022-23 CRA RISE test 3rd grade was 78% the state was at 40%
- Jessie likes to use all sorts of data to measure for programs.

Melanie and Jackie are wanting to ensure the funds are spread equally acrossK-6

Every teacher is on a team. The leadership team, the culture and climate team and the academic team. Jesse is over the academic team of teachers for the school. The input from the teams is that the lower grades are not satisfied with the intervention piece but 3-6 are. -Colleen

Lower grades are not satisfied with CKLA however the upper grades are.

- This program will replace the CKLA for K-2nd grades.
- 3-6 will continue with the current curriculum.

We are in need of new interventions. However we are unsure at this time if we can allocate just to intervention and not to a specific program?

Jesse is meeting with her team at the end of Jan. There might be a possibility of separating intervention and curriculum. She will update at the next Land Trust meeting.

(OT SUPPORTS FOR STUDENTS WITH 504S \$8,000.00-Colleen

Occupational Therapy supports students without a 504 plan. This is for students with special OT needs so they are able to access the curriculum better.
