

Meals at Canyon Rim Academy

Children need healthy meals to learn. **Canyon Rim Academy** offers healthy meals every school day. **Your children may qualify for free meals.** For the 2025-2026 school year, House Bill 100 has eliminated the category of reduced-price **lunch** meals. This year, all students qualifying for free or reduced meals will receive **Free Lunch Meals**.

Free & Reduced INFORMATION:

All students that received free or reduced meals last year will still receive those benefits for the first 30 days of the new school year or until a new application is received and processed.

TO APPLY: Printed applications for free meals are available in the office at any time throughout the year. A downloadable form can be accessed through the website. You may also apply online by registering for **Aspire**, the student information system, and **filling out the application online**. The information provided by the household is confidential and will be used only for purposes of determining eligibility and verifying data.

ELIGIBILITY: Children may receive free meals if your household income is within the limits on the Federal Eligibility Income Guidelines. (See chart below) All school-aged children in income eligible* households can receive school meal benefits regardless of the immigration status of household members, and information provided by the household will not be used for immigration-related purposes. Your children may qualify for free or reduced price meals if your household income falls at or below the limits on this chart:
